Tournament Guidelines

- Tournament Fee is **\$125**. Please make checks payable to **East Linn Christian Academy** and mailed to East Linn Christian Academy c/o Kellen Peters, 36883 Victory Dr., Lebanon, OR 97355
- Each team will need their own scorebook person and two line judges when their team is on duty.
- Teams must provide your own towels.
- Admission is \$5.00 for adults, \$3.00 for students.
- Warm-ups will be 5 minutes shared court.
- Each team will play three sets in pool play (*with a 25 point cap*).
- The top 4 teams in each pool will advance to single elimination bracket play.
 - The 1 and 2 seeds from each pool will play in the “Championship Bracket”.
 - The 3 and 4 seeds from each pool will play in the “Consolation Bracket”.
 - Best 2 of 3. First two sets to 25, win by 2, no cap. Third set to 15, win by 2, no cap.
- The winning team in the “Championship Bracket” will receive a trophy.
- A tournament MVP will be decided from the four teams in the “Championship Bracket”.
- Concessions will be available all day.
